[Things to keep note of in regards to pregnency and childbirth certification]

• "In case the desired month of usage falls within or two months before or after the month of childbirth," the certification will be based on pregnancy and childbirth requirements, regardless of the start date of maternity leave.

* However, Individuals who meet the certification requirements exceeding the pregnancy and childbirth criteria, such as employment etc. J, may change the criteria index used during the application process (admission selection) by submitting documents that prove those requirements.

 Prior to the 2023 fiscal year, if services were started based on pregnancy and childbirth requirements, the end of the certification period would result in withdrawal from the facility (or a reassessment through reapplication). However, starting from April 2024, this procedure will be abolished, and if continued use is desired, there will be no need for reapplication or reassessment, allowing for automatic continuation of services.

* However, if you take parental leave after the end of the pregnancy and childbirth certification period, you may continue using the service only if the parental leave period ends by the day before your child's first birthday. (If the parental leave extends beyond this period, you will be required to withdraw from the facility after the end of the pregnancy and childbirth certification period, so please be aware.)
